

CARSI Identity Federation Joining Statement

(for SP Members)

CERNET(China Education and Research NETwork) Authentication and Resource Sharing Infrastructure, abbreviated as CARSI Identity Federation, is an inter-institutional identity authentication and authorization federation initiated by Peking University. Based on Internet2 Shibboleth, CARSI adopts authentication and authorization middleware to enable federated authentication and resource sharing within CERNET.

1. Introduction

CARSI Identity Federation is owned by CERNET, aiming to promote services for universities, colleges, schools, levels of education administrative agencies and research institutions. The governance of the Federation is undertaken by CARSI Identity Federation Steering Committee and CARSI Identity Federation Operation Team jointly.

A Home Organization, also known as Identity Provider, IdP, is responsible for managing its users' electronic identities and for issuing assertions so that users may gain access to services. A Service Provider (SP) Organization is an organization which owns or controls access to online resources or services that users may wish to access. Service Provider Organizations grant access to these resources by licenses or other agreements either directly with the user's Home Organization or with some other bodies acting on behalf of the Home Organization.

2. Types of Federation Members

There are two types of Federation Members:

- a. **FULL Members.** MUST be a Home Organization and a member of CERNET. Universities, colleges, schools, levels of education administrative agencies and research institutions which are CERNET members at the moment can apply to be a FULL Member. The application can only be submitted by IT Governance Department, the Central IT Department or the Library.
 - a) They MUST deploy one and only one Identity Provider within the Federation to support campus local end users to access federation resources.
 - b) They MAY also optionally deploy Service Provider(s) to share campus local applications to national or international federation users.
- b. **Service Provider Members.** Referred by a FULL Member, an organization with the interests of serving Education and Research and /or be of benefit to the The Federation or its Members, can apply to be a Service Provider Member. A Service Provider Member can only deploy Service Provider(s).

In case of infringement on the rights and interests of the Federation or other third parties, my organization bear all responsibilities and compensate for all losses.

c. To cooperate with other members on an equal and mutually beneficial basis, do not interfere with the business development and normal operation of other members because of being a CARSJ member, and do not use resources, trademarks, logos, intellectual property rights and other legitimate rights of the Federation or other members without permission.

d. On the service website or service login page, put a CARSJ logo in an eye-catching way (such as without violating the use requirements of CARSJ for logo) to indicate that my organization is a member of the Federation or provide an independent federation login entry.
